

## Online Self-Assessment Resources for Law Professors and Students<sup>1</sup>

The chart below identifies free and fee-based resources to supplement online law teaching. The chart only includes resources with pre-built exercises and quizzes that provide students with instant feedback and full explanations for every question.

By assigning these resources, professors can assess student performance without “reinventing the wheel.” Importantly, the time needed for students to complete any online exercise counts toward the required ABA instructional minutes or out-of-class minutes.
